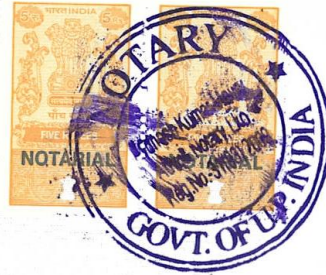
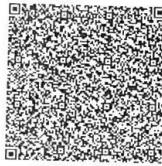

## **I. Legal Frameworks of Both the Organizations**

International Benevolent Research Foundation (IBRF) is a non profit and non political ISO 9001: 2015 organization incorporated under the Act II of 1882, Govt. of India vide no. 152400434 of 2015 having it's regd. Office at 48, Station Road, P.O and P.S- Rahara, Kolkata-700118, West Bengal, India.

Ambalika Institute of Management and Technology (AIMT) is a Private Engineering and Management College affiliated under the Dr. APJ Abdul Kalam Technical University, Uttar Pradesh and Board of Technical Education- Uttar Pradesh, having its campus at Maurawan Road, Mohanlalganj, Lucknow, Uttar Pradesh- 226301, India.

## **II. Purpose of the Agreement**

Given the interest of both the organizations to establish ties of academic cooperation in order to contribute to the achievement of their overall goals as institutions of peace education, conflict resolution, disarmament studies etc., this agreement seeks to create a multi-disciplinary, multi-level relationship **IBRF** and **AIMT** It does not purport to prescribe areas of collaboration, but rather to provide a framework to facilitate the exploration of specific actions that may be taken for the mutual benefit of the two schools. Potential areas include, but are not limited to:

1. To share and exchange of knowledge in the fields of academics and research with the faculties, students and research scholars.
2. Cooperative development, collaboration and conduct of various academic courses and programmes even with other organizations also.
3. Development of joint scientific and/or technological and management research projects.
4. Collaboration in the area of academic publications, research activities, field trips etc. with the faculties, students and research scholars.
5. To enroll and jointly conduct academic and research based programme like Graduation, Post Graduation, Ph.D and M.Tech (By Research) and different job oriented Certificate, Diploma, P G Diploma Programmes.
6. To hold and organize National and International Conferences in the different fields of Science, Technology, Management Education etc. including research methodologies, intellectual property rights, human rights etc.
7. Other activities of mutual interest regarding academic or scientific and technological research matters.
8. Conducting various Certificates, Diploma and Post Graduate Diploma level programmes under the Dr. APJ Abdul Kalam Technical University, Uttar Pradesh.
9. IBRF will assist in Green Audit, Energy Audit etc. to help achieve a good rank in NIRF-NAAC etc.
10. IBRF will help AIMT to establish a University or Autonomous Institution with the appropriate expertise and knowledge.



If additional guidance is required, both the organizations/ institutions will settle mutually after discussions.

## **III. Execution of the Agreement**

The specific activities to be carried out under this agreement will be stated in corresponding specific sub-agreements. Such specific sub-agreements, once approved by both parties, will be attached as annexes to this agreement.

The specific sub-agreements between both universities will specify their objectives, conditions and ways of execution, financial support, period the sub-agreement will be in effect, and administrative responsibility within each institution.

#### IV. Term and Expiration of the Agreement

It is understood that this agreement will come into effect after being signed by both Parties and will be established for a period of six (6) years. After this six year it will be automatically extended for an indefinite period, unless one of the Parties expresses an intention (by written notification) to cancel the agreement at least (3) three months before the expiry date.

Any additions, changes, or deletions to this document must be approved by these representatives of both organisations. All notices shall be in writing and shall be directed to these individuals as follows:

The amendment, termination and expiration of this MoU will not affect the terms of activities ongoing at the time of notification of amendment, termination or expiration, unless otherwise agreed upon between the parties.

#### V. NON-EXCLUSIVITY:

This Agreement is a non-exclusive agreement, and both parties remain free to enter into similar agreements with third parties.

#### VI. SPECIAL PROVISIONS

1. Each party will take approval from the other party in writing prior to using the latter's name and logo for the activities hereunder on a case-by-case basis.
2. All parties hereto shall do their utmost to ensure the smooth and efficient implementation of the programs.
3. The parties will consult with each other for any subsequent associated agreement informally and attempt to resolve disputes or misunderstandings that may arise in the administration of this MoU or any subsequent associated agreement informally.
4. Neither party can misuse this MoU by involving the name of the other without the written consent from the other party.

#### VII. DISPUTES

If any dispute arises in respect of the MoU, in that case both the organisations will discuss and settle the matter amicably.
