#### 1. Introduction

The academic policy document outlines the guidelines and regulations for students enrolled in the engineering programs at Ambalika Institute of Management and Technology. ## 2. Admission and Enrollment

- 2.1 Eligibility Criteria
- 2.1.1 Prospective students must meet the minimum eligibility requirements specified by the Dr APJ Abdul Kalam University (AKTU) for admission to the engineering programs.
- 2.1.2 Admission criteria may include academic qualifications, entrance examinations, counselling and other criteria as determined by the college.

## 2.2 Registration

- 2.2.1 Students must register for courses within the prescribed deadlines set by the Dr APJ Abdul Kalam University (AKTU).
- 2.3 Course Load
- 2.3.1 Students are expected to maintain a full-time course load as determined by the college.
- 2.3.2 Exceptions to the course load requirement may be granted in cases of extenuating circumstances, subject to approval.

#### 3. Curriculum and Degree Requirements

- 3.1 Program Structure
- 3.1.1 The engineering and management programs offered by the college follow a defined curriculum structure, which includes core courses, elective courses and any additional requirements as prescribed by the university.
- 3.1.2 Changes to the program structure, including modifications to the curriculum, will be communicated to students in a timely manner if university does so.
- 3.2 Course Requirements
- 3.2.1 Students must complete all required courses as specified in their respective programs.
- 3.2.2 Students may have the opportunity to choose elective courses from a predetermined list offered by Dr APJ Abdul Kalam University (AKTU), subject to departmental guidelines.
- 3.3 Minimum Grade Requirements
- 3.3.1 Students must achieve a minimum grade as determined by the university in all courses required for their program.
- 3.3.2 Failure to meet the minimum grade requirement may result in academic probation, repeat of the course, or other consequences as per college/University policy.

#### 4. Academic Performance and Evaluation

- 4.1 Attendance
- 4.1.1 Regular attendance in all classes, laboratories and examinations is mandatory.
- 4.1.2 Students failing to meet the minimum attendance requirement, as specified by the college/University, may be subject to disciplinary action and detention.

- 4.2.2 Evaluation criteria and grading schemes will be provided by the course instructors and communicated to students at the beginning of each course.
